City of Tallulah Regular Council Meeting August 9, 2018

A regular meeting of the Mayor and City Council was held on Thursday, August 9, 2018, at 5:30 P. M., in the Council Room Chamber of Tallulah City Hall.

Mayor Paxton J. Branch called the meeting to order, led the Pledge of Allegiance, and Councilmember Whitney gave the invocation.

Mayor Branch allowed a brief public comment period in which comments would be limited to the agenda items and would be no more than three minutes in length. Councilmember Whitney asked that an item concerning city personnel be placed on the agenda. Subsequent motion and second to amend the agenda were made by Councilmembers Sims and Robinson respectively, but the motion did not carry due to the requirement that an item added to the agenda must receive a unanimous approval vote from the Council which did not occur.

Motion and second to approve minutes of the July 26<sup>th</sup> meeting were made by Councilmembers Day and Finlayson respectively and carried unanimously.

City Superintendent, C. J. Oney reported to the Mayor and Council that recent efforts in public works included; removal of abandoned houses, filling of pot holes, resurfacing portions of some streets; cleaning parks, clearing street gutters, and removing fallen trees. He also noted that the Harlem Street Project was coming along successfully and is currently awaiting the installation of cement culverts.

Councilmember Finlayson moved for approval of a Cooperative Endeavor Agreement between the City of Tallulah and the Foundation of Louisiana Students, d/b/a, University View Academy, a Louisiana Nonprofit Corporation ("UVA"). Councilmember Day seconded, and motion carried unanimously.

Motion and second by Councilmembers Robinson and Whitney respectively to approve a Corporate Endeavor Agreement between the City of Tallulah and Step by Step Performing Arts Academy, Inc., carried unanimously.

Up for approval was a Resolution Approving Mayor Paxton J. Branch to Make Application to the Division of Administration, Office of Community Development Community Water Enrichment Fund for Funds in the Amount of \$26,900, to Supplement DRA Funds in the Amount of \$150,000 for Repairs to Clarifier No. 1 at the Existing Water Treatment Plant. A representative of McManus Engineering firm, Monroe, Louisiana explained the utmost importance of replacing the one remaining water plant clarifier and the dire consequences should the one in use fail. Subsequent motion for approval of the Office of Community Development grant application was made by Councilmember Finlayson, seconded by Councilmember Day, and a roll-call vote is listed as follows:
