Customer rate increase: Residential \$11.25 to base (first 1000 gallons) and \$3.30 per 1,000 gallons thereafter; Commercial \$41.00 to base (first 1000 gallons) and \$3.35 per 1,000 gallons thereafter

ii. USDA Financing - \$13,794,210 (40 years at 2.5% to 4%; Debt Service Annually \$560,000 to \$725,000)

Customer rate increase: Residential \$10.000 to base (first 1000 gallons) and \$1.20 to \$3.00 per 1,000 gallons thereafter; Commercial \$35.00 to base (first 1,000 gallons) and \$1.70 to \$2.75 per 1,000 gallons thereafter
