Superintendent's Report:

Mr. David Day advised the council that the department was doing well and that they are continuing to patch holes in the roads, cleaning ditches and cutting grass.

Water Operator's Report:

In the absence of Mr. Goods, Ken McManus of McManus Engineering stated that a study on all components of the water plant needs to be done to see if they needed to be replaced or rebuilt. If the plant is remodeled all parts will be new. The ground storage tank as well as the elevated tank needs to be replaced. All pumps will be replaced. An estimated cost for a loan for forty year will be 7.8 million to rebuild the plant and 11.6 for a new plant. Councilmember Scott asked if a new well would still be needed, and the answer was yes, it was out for bids already. Antonio Wilson questioned would the rates increase and what is the plan to pay for the new plant. Mayor Finlayson asked all Council Members to meet with Ken McManus to discuss all questions/concerns they have.
