

Regular Council Meeting
City of Tallulah
June 23, 2021

A regular meeting of the City Council was held on Wednesday, June 23, 2021, at 5:30 pm in the Council Room Chamber of Tallulah City Hall.

Mayor Charles M. Finlayson called the meeting to order, led the Pledge of Allegiance and allowed for moment of silent prayer.

At Mayor Finlayson's suggestion, an item regarding reappointment was placed on the agenda with subsequent motion and second from Councilmembers Day and Whitney respectively which carried unanimously.

Councilman Robinson moved for approval of the minutes of June 9, 2021, with second from Councilman Whitney, and motion carried.

Cedric Floyd, President, Data Center, Kenner, Louisiana, made a presentation to the Mayor and Council regarding redistricting for the 2020 Decennial Census. He elaborated on the experience and capabilities of his company and asked that the Mayor and Council consider him in choosing a redistricting service.

Former Mayor Gloria Hayden commented on the agenda indicating that she would have further comments regarding agenda budgetary items as they were acted upon by the Council.

Motion and second to enter Public Hearing were made by Council members Whitney and Day respectively and carried unanimously.

Subsequent motion to adjourn Public Hearing and re-enter Regular session was may by Councilmember Whitney, seconded by Councilmember Day, and carried unanimously.


