A Regular Meeting of the Mayor and City Council was held on Thursday, January 23, 2024 at 5:30 P.M., in the Council Room Chamber of Tallulah City Hall. The meeting began with the Pledge of Allegiance followed by a prayer by Councilmember Wells.
